

RESOLUTION 2023-33

A RESOLUTION TO ESTABLISH STREET AND SIDEWALK PERMIT FEES FOR THE BOROUGH OF BRISTOL

Whereas, the Council of the Borough of Bristol desires to establish and amend street and sidewalk permits fees for the Borough of Bristol as provided by Chapter 21 of the Borough Ordinances;

Now, Therefore, be it resolved by the Council of the Borough of Bristol, it is hereby resolved by the authority of same that the Street and Sidewalk Fees are hereby amended as follows:

Part I – Chapter 21: Streets

I. Pursuant to Section 21-110: Permit Fee to Excavate Borough Streets

<u>Size of Excavation</u>	<u>Permit Cost</u>
Up to 40 Square Feet	\$246.00
Over 40 Square Feet	\$246.00 and \$2.46 for every square foot of excavation over 40 feet*

*Permit Fee is based on area of roadway trenched. However, final road restoration is subject to review by the Borough Engineer, in accordance with the Bristol Borough Roadway Opening Repair Standards.

II. Pursuant to Section 21-122: Escrow for Engineer and Inspection for Streets

<u>Size of Excavation</u>	<u>Permit Cost</u>
Up to 40 Square Feet	No Fee
Over 40 Square Feet	\$1,845.00 or 10% of excavation fee, whichever is higher

III. Pursuant to Section 21-123: Security Escrow for Streets

<u>Size of Excavation</u>	<u>Permit Cost</u>
Up to 40 Square Feet	\$1,845.00
Over 40 Square Feet	100% of the Excavation Permit Fee

Part 2 – Chapter 21: Sidewalks

IV. Pursuant to Section 21-222: Permit Fee to Excavate Borough Sidewalks

<u>Size of Excavation</u>	<u>Permit Cost</u>
Up to 40 Square Feet	\$246.00
Over 40 Square Feet	\$246.00 and \$2.46 for every square foot of excavation over 40 feet

V. Pursuant to Section 21-212: Escrow for Engineer and Inspection for Sidewalks

<u>Size of Excavation</u>	<u>Permit Cost</u>
Up to 40 Square Feet	No Fee
Over 40 Square Feet	\$1,845.00 or 10% of excavation fee, whichever is higher

VI. Pursuant to Section 21-213: Security Escrow for Sidewalks

<u>Size of Excavation</u>	<u>Permit Cost</u>
Up to 40 Square Feet	\$1,845.00
Over 40 Square Feet	100% of the Excavation Permit Fee
